

TERMS OF SERVICE

These terms of service became effective on 15.04.2019

These Terms of Service (the “Terms”) are a legal and binding agreement between you and Webtech International L.P. a company incorporated in Lanark, UK with company number SL025287 whose registered office is at ‘44 Main Street Douglas Lanark ML11 0QW United Kingdom ’ (“Webtech International L.P.", "us", “our” or "we") under which we license all games and applications made available by us (jointly and interchangeably referred to as the “Services”).

We reserve all rights not expressly granted in the Terms, including, without limitation, title, ownership, intellectual property rights, and all other rights and interest in our Services, and all related items.

Acknowledgements

From time to time, updates to the App may be issued through the App store. Depending on the update, you may not be able to access our Services until you have downloaded the latest version of the App and accepted any new terms.

You acknowledge that in order to access the App, the Device must have an internet connectivity of 3G and above or Wi-Fi. We will not be liable for any delay in time caused owing to any deficiency in speed of your internet connectivity or any interruption such as a phone call or the receipt of an SMS during a quiz or any other defect thereof at your end or on your Device.

15. GAME RULES AND CONTESTS

All games have 12 questions and you have a maximum of 10 seconds to answer each question.

The grand prize is divided between all remaining competitors who have answered all the questions correctly.

PRO Games: offers just cash prizes.

- Premium and Standart users are both able to join PRO Games under the same terms.
- Premium Users can gain life through their subscription package type.
- Standart users can buy life during the game or buy it from the market in the application.
- If everyone gets eliminated in PRO games, the prize rolls over to the next PRO game.

(Webtech International L.P. is the sponsor of all prizes that are competed for during the games.)

Life: Users will be able to buy life for the real money from the market in the application.
